Logistical issues	<p><i>What are the implications of the new agreement for buildings, office space, transportation, other properties, etc.?</i></p> <p><i>Are there adequate facilities to house all personnel, equipment and programs within reasonable geographical proximity to the customers for the shared services?</i></p>	

6. Communications	<p><i>How will the parties communicate?</i></p> <p><i>Are there external audiences with whom the partners also should communicate? If so, is there a strategic communications plan in place?</i></p>	
7. Change management	<p><i>What changes will occur as a result of the CJS arrangements?</i></p> <p><i>Who will be affected? How will changes be managed?</i></p>	
8. Timeline	<i>Is there a timeline including specific steps that have to be taken for the success of the sharing initiative?</i>	
9. Monitoring	<p><i>How would you know if the CJS initiative is successful?</i></p> <p><i>How would the partners measure success?</i></p>
